## **Rules for Migration From other University**

The provision for migration of students from other universities is as detailed below:

- 1. Migration to the Rayat Bahra University from other Universities shall be permitted only if the concerned university should have an affiliation in any of the Professional bodies such as AIU/AICTE/UGC etc.
- 2. The student shall be permitted to migrate only if he/she fulfils the Rayat Bahra University Eligibility criteria for admissions to the course applied for migration.
- 3. The migration shall be permitted only up to the seventh semester of the B.Tech program and half the duration of the program in the case of other programs.
- 4. The admission shall be offered on a migration basis through the lateral transfer of credits.
- 5. The students shall be allowed to migrate to the University subject to satisfying the rules and regulations of the University as regards, the maximum number of backlogs, grade points, minimum credit requirements for promotion to higher semesters, etc.
- 6. The student shall be offered admission to any of the affiliated Schools/institutions of the University subject to the availability of seats. The student shall produce "NO OBJECTION CERTIFICATE" from the concerned college/institute/University in this regard.
- 7. The students offered admission shall have to take transitory courses/additional subjects of the previous semesters to satisfy the program requirement as recommended by the concerned Board of Studies.
- 8. The student offered admission shall pay the migration fees of Rs.100/- and the University Course fees as prescribed by the University. The application form fee shall be Rs.1000/- (Rupees one thousand only).
- 9. The migration fee will be charged by the Examination Deptt. for the expenses of the concerned Deptt. to decide on the student suitability for migration and to recommend the transitory courses/additional subjects to be studied by the student to fulfill the academic requirement of the University.
- 10. The Course fee once paid shall not be refunded under any circumstances.
- 11. The migrated students shall follow the rules and regulations of the University.
- 12. The students offered admission shall produce a migration certificate from the concerned University at the time of admission.

- 13. The student offered admission shall produce a character certificate from the parent institute/University at the time of admission.
- 14. Regulations, Scheme, and Syllabus of the respective specialization attested by the Registrar of the concerned University or equivalent authority shall be submitted to the University along with the application seeking migration to the University.
- 15. Attested copies of all certificates and mark lists from 10th onwards shall be submitted along with the application for migration(Original Certificates and mark lists shall be produced as and when required by the University).
- 16. Assessment of the student suitability for migration in terms of programs, backlogs, grade points, credit requirements, etc shall be done by the Examination Deptt. Or by Dean Academic Affairs.
- 17. Assessment of the transitory courses/ additional courses to be done by the student as per the academic requirement of the University shall be as recommended by the Examination Deptt. or by Dean Academic Affairs.
- 18. No student will be migrated if he/she has a reappear in any subject of previous University from where he/she is migrated.

## Rules for Migration From Rayat Bahra University to another University

- 1. There will be no migration in Postgraduate courses, because of the limited period of degree.
- 2. In the case of undergraduate courses, migration will be restricted to the 3rd semester only. After that, no migration will be allowed.
- 3. No student will be migrated if he/she has a reappear in any subject of previous exams conducted by Rayat Bahra University.
